Prompt – Imagine that you are somehow sent back in time to Scandinavia at the height of the worship of the Norse gods – between the 13th Century BCE and the 3rd Century CE. You may or may not choose to explore a period in which the "Christianisation" of Scandinavia was taking place as a point of contrast.

Keep a log of your daily experiences and insights in the hope that if you are able to return to your own time, you can inform others of what you have learned and experienced.

In your log, you need to deliver a comprehensive picture of the society and time with close reference to:

- their beliefs about origins of the universe

principal beliefs

supernatural powers and deities

rituals

- influence in the society and

- human search for meaning.

These elements will need to be creatively and thoroughly explored within the fictional text you create. Please find a copy of the two syllabus pages relevant to Religions of Ancient Origin. Use these pages as your guide to ensure that you include reference to all relevant information that you will need to include in order to do this well.

You may record this log as:

- a) a piece of historical fiction in prose approx 1000 words broken into individual diary/journal/log entries OR
- b) a photo essay of ten images explained by 600 words of text to justify your selection of these images you can imagine that somehow you had your phone and solar charger with you to enable you to take these photographs but obviously they'll be images of ruins or archaeological evidence you find in your research. To be delivered in a Ppt file with text embedded in slides that follow each image slide OR printed photos in a folder/scrap book or similar with printed text beside each image.
- c) a vlog of separate entries totalling no longer than 30 minutes duration which you must be able to deliver to me without any technical issues.* This option will also need to be submitted with a complete transcript. OR
- d) An audio file of separate entries no longer than 30 minutes duration which you must be able to deliver to me without any technical issues.** This option will also need to be submitted with a complete transcript.

^{*} No extra time will be allowed in case of technical difficulties so only choose this option if you are 100% confident that you know how to get your single, carefully-edited video file of no longer than 30 mins to me in a format I can view and mark with no additional challenges.
